I AM AWARE MY PARTICIPATION IN THE TOURNAMENT, LISTED ON MY ENTRY FORM CREATES THE RISK OF SERIOUS INJURY OR DEATH. BY PARTICIPATING, I REALIZE I MAY EXPERIENCE LOSS OR DAMAGE TO PERSONAL PROPERTY. 3. I will comply with all rules and regulations. If I have any question, or observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest official; and
